How Auto Navigator Works

Use Auto Navigator to pre-qualify for auto financing prior to visiting an eligible dealer. We review the information you provide to determine whether you pre-qualify with no risk to your credit score. If you pre-qualify, you will be able to see your estimated monthly payments and APRs for vehicles you may be considering. You will receive an Auto Navigator financing certificate, which includes an estimate of the financing terms you could qualify for when you apply for financing at the dealer. When you are ready to finance a vehicle, take your Auto Navigator financing certificate to an eligible dealer to let them know you are pre-qualified for auto financing with Capital One. Remember, you can use your mobile phone to configure vehicles and compare your options at the dealer.

Product Terms

Pre-qualification does not guarantee that you will receive financing or any particular financing terms, which are subject to change based on our evaluation of your credit application submitted at the dealer and any required documents. Auto Navigator terms expire 30 days from the date you pre-qualify. To pre-qualify, you must be at least 18 years old and have a valid street address within the United States or an APO/FPO address. Minimum monthly income is \$1,500 or \$1,800 depending on credit history. Any existing Capital One accounts must be in good standing.

Using Auto Navigator at a Dealer

When you visit an eligible dealer, show them your Auto Navigator financing certificate, fill out a credit application and provide any information needed for review to complete your financing. A credit application at the dealer will result in one or more inquiries posted to your credit file. After negotiating purchase terms and receiving dealer credit approval, you will sign a contract with the dealer reflecting both your purchase and financing terms. Your purchase will result in a retail installment contract with the dealer as the original creditor. [See our FAQs](#) for more information.

Amount Financed Restrictions

For new and used vehicles, the minimum Amount Financed is \$4,000 and the maximum Amount Financed is \$40,000 (excluding any warranties or GAP). Your maximum Amount Financed may be based on the value of the specific vehicle you are purchasing. The Amount Financed may include the vehicle sales price, tax, title, licensing fees, dealer fees, and any optional products like GAP coverage and extended warranty that you choose to purchase from the dealer. Cash down may be required in order to complete your purchase.

Dealer Eligibility Requirements

Capital One Auto Finance provides financing for new and used vehicles purchased from eligible dealers listed on our [Dealer Locator](#). We do not offer financing for vehicles purchased from non-eligible dealers, auto brokers or private-party sellers. We do not offer financing for lease buyouts.

Vehicle Type Restrictions

Auto Navigator terms can only be used at eligible dealer locations in connection with the purchase of a new or used car, light truck, minivan or SUV intended for personal use. Vehicle model must be 10 years or newer and have less than 120,000 miles. We do not finance Oldsmobile, Daewoo, Saab, Suzuki or Isuzu vehicles. We do not offer financing for commercial vehicles, motorcycles, recreational vehicles (RVs), ATVs, boats, camper vans, motor homes, lemon vehicles, branded title vehicles, lease buyouts, or vehicles without a vehicle identification number (VIN) or title issued. We may determine a vehicle to be commercial or otherwise ineligible based on the model and/or information provided to us.

Vehicle model must be 2005 or newer and have less than 120,000 miles. Note, if you are a resident of AA, AE, AP, CT, DC, DE, GA, IL, IN, KY, MA, MI, ME, MD, MN, NC, NH, NJ, NY, OH, OR, PA, RI, SC, VA, VT, WA, WV or WY, or you pre-qualified before June 2, 2017, then vehicle model must be 2007 or newer.

Dealer-Advertised Inventory

Dealer advertised inventory might not be available for all eligible dealers. If dealer advertised inventory is not available in Auto Navigator, or if the inventory is not available in your market, your Capital One pre-qualification may still be used at any eligible dealer.
